LETTER FROM OUR PRESIDENT AND CEO

Dear Friend,

This year tested all of us.

During the first year of Donald Trump's second term, his administration unleashed a wave of chaos—attacks on health care, attempts at backdoor abortion bans, and a steady stream of lies meant to confuse and divide us. Every day seemed to bring a new threat to our rights and freedoms.

So we got to work.

We tracked the bills and nominees that would strip away our rights. We spoke loudly and clearly about what was happening. We launched our podcast to have honest conversations about what abortion bans are really doing to people's lives and to reach new audiences. We mobilized tens of thousands of people across the country to push back against efforts to gut Medicaid, defund Planned Parenthood, and sneak abortion restrictions into the Affordable Care Act (ACA). And in November, voters loudly declared what we already knew—people want abortion access, and they will show up to protect it.

We started the year fighting, and we are still fighting, because the stakes couldn't be higher. We fight because our futures and freedoms are on the line. We fight for the people who have suffered, been traumatized, or died because of abortion bans—people who often face systemic racism and barriers to care, particularly those who are Black, brown, low-income, disabled, undocumented, transgender, young, or living in rural communities.

We fight to end the silence, fear, and shame created by these attacks.

We fight for you. Alongside our 4.5 million members, we fight to protect reproductive freedom for everybody.

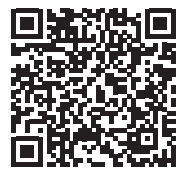

Driving Accountability

Holding Republicans Accountable for the So-Called ‘Beautiful Bill’

OUTRAGEOUS

Republicans further entrenched the country in a deadly health care crisis in July when they passed Trump’s so-called “One Big Beautiful Bill,” gutting Medicaid, defunding Planned Parenthood, **ripping health care away from 16 million people, and amounting to a nationwide backdoor abortion ban.**



ACCOUNTABILITY: With so many GOP lawmakers hiding from their constituents during August recess, we hosted events and town halls in their districts, while launching “Missing Persons” billboards and posters in key states including Arizona, California, and Nevada.



EDUCATION: We leveraged research from battleground districts to drive the narrative—through the media, op-eds, and messaging—that the majority support reproductive freedom, and to ensure that communities across the country knew the consequences of this budget bill. **Our six-figure ad buy in target districts (AZ-01, AZ-06, CA-22, MI-07, PA-07) called out Republicans for threatening access to affordable health care and putting Planned Parenthood—one of the largest care providers for Medicaid patients—at risk.** Our ads successfully engaged and motivated voters across the political spectrum, including Republicans by double digits.



ACTION: We equipped our members with activist toolkits to help anyone take action—from anywhere—whether calling and writing their lawmakers or organizing people online. **During August recess, our members made 6,900 calls and sent 61,300 texts in key states** such as Pennsylvania and Wisconsin, **while recruiting almost 8,000 new members and dozens of new volunteers.** We also hosted events, including Rights Nights, where members held house parties to educate their communities on the Republican budget, share stories, and hold their representatives accountable.

We’re not letting up—we kept up the pressure in 2025 and into 2026 to hold accountable elected leaders who voted to gut Medicaid and defund Planned Parenthood. In February 2026, we launched an additional five-figure digital ad buy in key districts to remind voters that these leaders voted to raise health care costs for their communities and families.

Shaping Policy

We're facing a flood of political posturing and life-threatening attacks. Trump lied—he's not leaving abortion access to the states—and federal efforts that effectively ban abortion would block access across the country.



Our government relations team works at the state and federal levels to advance Repro for All's policy priorities. They lobby legislators to protect and expand abortion access and prevent new restrictions. They track and analyze legislation, regulations, court cases, and nominations, ensuring our lobbying, communications, and organizing efforts are informed, effective, and strategic. They also work behind the scenes, equipping elected leaders with the information they need to champion reproductive freedom.

In 2025, Trump and his circus of extremist allies attacked our fundamental rights in historic fashion, including relentless attacks on abortion, health care, and bodily autonomy. This is not surprising—they told us their plans. So we organized to fight back.

Here are just a few ways our government relations team worked to protect our rights in 2025.



Holding lawmakers accountable to the values of the 8 in 10 Americans who support legal abortion. We stopped unprecedented restrictions on abortion access from being added during negotiations to extend Affordable Care Act (ACA) tax credits. We worked with members of Congress early to provide research, co-host briefings, and talk to elected leaders about the need to stop new restrictions—while keeping the issue front and center in media coverage, and activating our members to send 4,000 messages to Congress.



Monitoring state and federal legislation. We researched over 1,000 bills across all 50 states that could affect abortion access. When South Carolina tried to pass a total abortion ban, our team worked with our allies in the state, submitting testimony and mobilizing our members in South Carolina to call their state lawmakers. The bill ultimately failed.



Sounding the alarm on the Trump administration's nominees. We opposed 25 cabinet and judicial nominees—researching their records, sending reports to support senators during committee hearings, submitting letters opposing nominees on record, and lobbying elected leaders to vote against confirmations. We also put a public spotlight on nominees—launching a six-figure ad campaign hitting Trump for packing his cabinet with anti-abortion extremists, and mobilizing 18,000 people to take action and send 36,000 messages to their senators demanding they oppose anti-reproductive freedom nominees.



Collaborating with coalition partners. We need to be strategic and coordinated, which is why Repro for All works with national partners to advance federal legislation that protects and expands abortion access while pushing back against attacks on our rights. We collaborate with partners in the broader progressive movement, including civil rights and democracy organizations on voting rights and fair courts issues. And we work closely with partners at the state level to strategize on policy, organizing, and communications on reproductive freedom issues.

Organizing the Next Generation

National Youth Action Council

Our 60-member National Youth Action Council is made up of Gen Z and younger millennial volunteer leaders ages 18–30 who are committed to advancing reproductive freedom. We support and equip these leaders with the skills, tools, and training they need to build and lead teams in their communities while organizing around national reproductive freedom issues at the local level.

PRIDE

Repro for All was part of 16 Pride events across the country in 2025, including in Washington, DC; Phoenix; Atlanta; Reno; and St. Petersburg, Florida, giving us a chance to connect with younger activists in an intersectional space. We signed up new members, talked about repro freedom issues, and recruited volunteers to join our 2025 Activist Summit!

Campus Program

Repro for All is organizing and mobilizing the next generation of activists who will lead this fight in the future!

Our campus program is **GROWING!** We have clubs or campus organizers in all five chapter states—Arizona, California, Georgia, Michigan, and Nevada—as well as Oregon, Pennsylvania, South Carolina, Texas, and Virginia! To support student organizers, we equipped them with our new campus organizing toolkit and hired interns dedicated to helping campus groups run events and recruit members. **They have recruited approximately 600 volunteers and members across campuses nationwide.** These volunteers run voter registration tables, help with phone banks, and participate in events on campus.

In 2025, our Michigan chapter hosted a statewide college tour—in response to student demand—at schools such as Wayne State and Michigan State. We met with students to discuss the state of reproductive freedom and how they can take action, with many committed to future organizing!

Mobilizing in the States

Reproductive Freedom for All's state chapters build grassroots and political power to engage and mobilize communities, lobby state lawmakers, and advocate for reproductive freedom.

Last year, **our chapter states hosted nearly 400 events in their communities**, including town halls, phone banks, parades, and protests. We also recruited **1,540 new active volunteers** and moved over **37,000 new people to take action with us**.

Here are a few examples of the impact our chapter states made throughout the year.

ARIZONA

97,473

During August recess, Reproductive Freedom for All Arizona hosted the "Sleepy Schweikert Snoozefest," a **pajama protest to hold Rep. David Schweikert accountable for sleeping through a major vote on the federal budget bill**, which made deep cuts to Medicaid and defunded Planned Parenthood. Nearly 100 people gathered in their pajamas to write letters to Schweikert's office and hear from community members directly affected by Medicaid cuts.



CALIFORNIA

Reproductive Freedom for All California members made their voices heard in 2025! During the August recess, members hung up and **projected "Missing Person" flyers** of Reps. Ken Calvert (CA-41) and David Valadao (CA-22), calling them out for **hiding from their own constituents**. Both representatives voted for Trump's budget bill, which resulted in major cuts to Medicaid, despite promises to protect Californians' access to health care.



GEORGIA

Georgia members came together to meet with lawmakers and push back against extremist policies for the **2025 Lobby Day** with our coalition. A powerful press conference followed, featuring remarks from Rep. Shea Roberts (GA-52), Senate Minority Leader Harold Jones (GA-22). Each speaker brought the same resounding message: **The fight for reproductive freedom is urgent, and we won't back down.**



MICHIGAN

Our Michigan team co-hosted and sponsored our joint Capitol Day with Michigan United and other partner organizations to advocate for state funding for Planned Parenthood of Michigan. More than **400 people from across the state attended, and we hosted a powerful youth panel on reproductive freedom.**



NEVADA

During Nevada's 2025 legislative session, **15 reproductive freedom-related bills were introduced, four of which were signed into law.** Our team worked closely with a broad coalition of partners to advance our priorities, and members of **our staff provided testimony in support of eight bills** across state Assembly and Senate committees. In June, Reproductive Freedom for All Director of Nevada Campaigns Denise Lopez joined State Senate Majority Leader Nicole Cannizzaro and Attorney General Aaron Ford to condemn Gov. Joe Lombardo's veto of SB 217, a bill that would expand in vitro fertilization coverage significantly.

Leading the Conversation

Repro for All is shaping public opinion by keeping people informed and engaged. When news about reproductive freedom breaks, Repro for All is there—using our platform to expose extremism and its harms, informing people about the real state of reproductive freedom across the country, and mobilizing them to action.

Reaching New Audiences

We're working with influencers and other recognized content creators in lifestyle, parenting, wellness, and culture spaces to reach audiences who don't typically consume political content—empowering them to increase awareness and help their audiences, especially the rising generation of younger voters, understand the ongoing impact of attacks on reproductive freedom.



Expanding to New Platforms

Mini Timmaraju joined podcasts including “How to Change the World,” and “The Great Battlefield Podcast,” and participated in several Substack Live events, including one with writer and activist Jessica Valenti—one of the most influential voices on gender—to discuss mifepristone and its role in abortion access.

Growing Our Digital Reach

In 2025, we significantly **expanded our social media reach**, growing our overall audience by 256%. That growth means more people engaging with our educational content, more supporters we can mobilize to take action, and more opportunities to recruit members and volunteers.





Elevating Storytellers

We are building communities of volunteers to share personal stories about reproductive freedom and abortion, affirming their lived experiences and moving people to action. We know that when we share personal experiences about abortion access and why we fight for reproductive freedom, we help others understand what's at stake and why it's so important to act now.

Driving the Media Narrative

We're using strategic messaging and education tools to engage the press while amplifying the voices of movement leaders such as Mini Timmaraju—ensuring our messages reach and resonate with the public. In 2025, Repro for All was featured in over 30 MS NOW TV segments, and we had multiple op-eds published in outlets across the country.

Electing Repro Freedom Champions

Get Out the Vote 2025

From California to Virginia, voters delivered decisive victories for reproductive freedom.

In 2025, voters used the ballot box as a megaphone to loudly declare what we already knew—people want abortion access, and they will show up to protect it.

Repro for All launched the “Your Vote, Your Freedom” campaign, a \$5 million electoral program to mobilize voters, hold anti-abortion extremists accountable, and defend against attacks on reproductive freedom in key states. After months of organizing, outreach, and hard work, we saw powerful results:

- ✓ **In California, we showed that democracy is not up for grabs with the passage of Proposition 50.** Prop 50 allows congressional maps in the state to be temporarily redrawn to offset Republican gerrymandering efforts in Texas. It's a critical step toward ensuring that democracy and fairness prevail in the 2026 elections and beyond.
- ✓ **In New Jersey, we elected as governor outstanding repro freedom champion Mikie Sherrill,** who pledged to enshrine abortion rights in the state constitution, safeguard access to mifepristone, and defend Planned Parenthood.
- ✓ **In Virginia, we secured a historic trifecta,** with victories for Abigail Spanberger as governor, Ghazala Hashmi as lieutenant governor, and Jay Jones as attorney general, while expanding the majority in the House of Delegates—the first time since 2019 that Democrats have full control of the state government.
- ✓ **In 2025, we also educated and mobilized voters on the critical role of the state Supreme Court**—electing Susan Crawford in Wisconsin's April special election. We also retained all three endorsed Pennsylvania Supreme Court justices, ensuring Pennsylvanians will continue to have fair-minded, impartial judges to uphold their most fundamental rights, including abortion access.

ELECTIONS MATTER

Just days into 2026, the **Virginia Senate passed the Virginia Right to Reproductive Freedom Amendment**—a measure to enshrine the fundamental right to reproductive health care, including abortion, in the state constitution. The amendment's passage was **made possible by the outcomes of the 2025 elections**, and Virginians will have the opportunity to vote on the measure in November 2026.

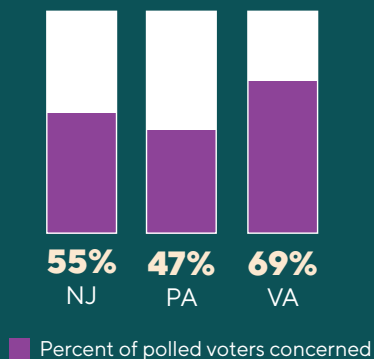
Abortion Is a Winning Issue

Not only did all of our endorsed candidates win their races in 2025, but exit polls show abortion played a crucial role in those victories.

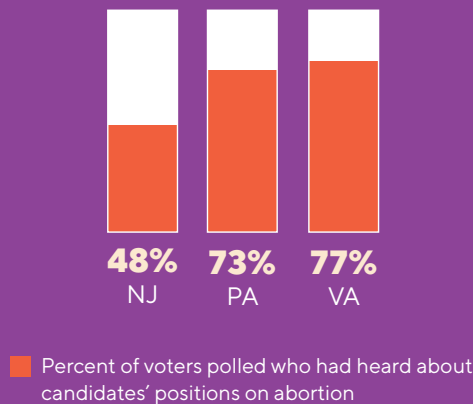
Exit polling from Repro for All and Impact Research in New Jersey, Pennsylvania, and Virginia shows that abortion was highly influential in voters' decision-making for the 2025 election cycle—proving that abortion and reproductive freedom remain a powerful and galvanizing issue for voters.

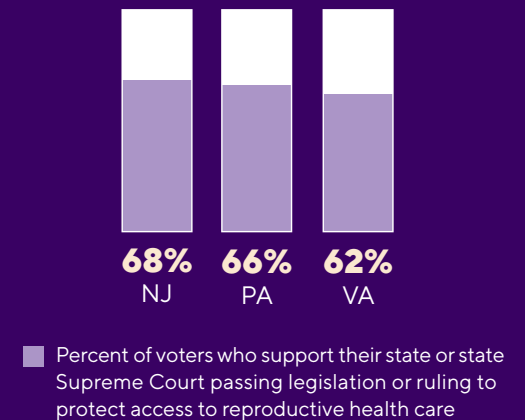
Candidates who aligned themselves with an extreme anti-abortion agenda lost. In New Jersey, Pennsylvania, and Virginia, a majority of voters worried their states would see more restrictions on abortion if Republicans won.



Abortion broke through the noise—a majority of voters heard about repro freedom champions' position on abortion.



A majority of voters want their elected leaders to make reproductive freedom a priority and to see more protections for abortion.



Voters sent a clear message this election cycle: Reproductive freedom is nonnegotiable.

Candidates who committed to protecting abortion care and reproductive freedom won, while those who sought to roll back these rights were soundly rejected at the ballot box.

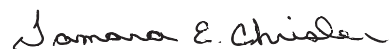

Based on data from our performance management process, **our 2025 training plan offered refreshed training programs designed to help fill skill gaps within the organization** while being responsive to staff's needs, e.g., finding more in-person training opportunities and identifying specific areas employees want training in to help with their stretch goals.



Using 100% staff input, we launched a wellness program designed to provide the resources and support employees said they needed most.

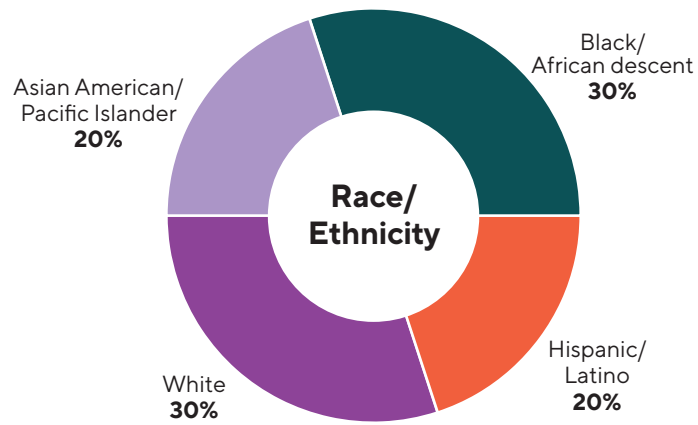
